HAPPYU TERMS AND CONDITIONS

Article 1. INTRODUCTION AND ACCEPTANCE OF TERMS

Welcome to the official website of Happy U FZE ("we," "us," or "our"). These Website Terms and Conditions ("Terms") govern your access to and use of our website, including any content, functionality, and services offered through it (collectively, the "Website"). "Happy U Enterprise L.L.C-FZ" maintains the https://happyu.ae/ Website ("Site").

By accessing or using this Website, whether as a guest, registered user, or collaborator, you agree to be legally bound by these Terms. If you do not agree with any part of these Terms, you must not use or access this Website.

These Terms form a legally binding agreement between you and Happy U FZE, a company incorporated and operating under the laws of the United Arab Emirates, with its registered address in the Meydan Free Zone, Dubai. Please read these Terms carefully before using the Website.

Article 2. DEFINITIONS

- 2.1. For purposes of these Terms and Conditions, the following terms shall have the meanings set forth below. Defined terms apply throughout this document unless otherwise specified:
 - a. "Website" means the online platform owned and operated by Happy U FZE, including all subdomains, content, services, and features accessible at or through www.happyu.ae or any other designated domain.
 - b. "User" means any individual or entity accessing, browsing, interacting with, or using the Website, regardless of whether they register an account.
 - c. "Registered User" means a User who has successfully created an account or profile on the Website to access additional features or participate in community or service offerings.
 - d. "Content" means all data, materials, text, graphics, videos, audio files, images, software, code, designs, and other information made available on or through the Website by Happy U or its users.
 - e. "Happy U" or "Company" means Happy U FZE, a company incorporated under the laws of the United Arab Emirates, with its principal place of business in the Meydan Free Zone, Dubai.
 - f. "Platform" means the full suite of digital services, tools, forums, modules, content, programs, features, and other user interfaces made available by Happy U through the Website.

- g. "Wellness Content" means any articles, tools, exercises, prompts, coaching material, resources, or programs made available through the Website intended to support personal development, emotional wellbeing, or holistic wellness.
- h. "Acceptable Use Policy" means the guidelines outlined in these Terms that govern how the Website and Platform may be lawfully and respectfully used by Users.
- i. "Third-Party Services" means any software, platform, application, payment processor, or content provided by a party other than Happy U that is accessible through or integrated with the Website.
- j. "Applicable Law" means all laws, regulations, rules, and legal obligations enforced by the United Arab Emirates, including those of the Emirate of Dubai and the Meydan Free Zone, as may be amended from time to time.

Article 3. ELIGIBILITY AND USER RESPONSIBILITY

- 3.1. Minimum Age and Capacity: By accessing or using the Website, the User represents and warrants that they are at least eighteen (18) years of age or the age of majority in their jurisdiction, whichever is higher, and possess the legal capacity to enter into binding agreements under Applicable Law. If the User is accessing the Website on behalf of an entity or organization, they affirm that they are authorized to act on its behalf and to bind it to these Terms.
- 3.2. Account Registration and Security: Where registration is required, the User agrees to provide accurate, complete, and updated information and to maintain the confidentiality of their account credentials. Article 4. PAYMENTS & BILLING POLICY

- 4.1. Visa or MasterCard debit and credit cards in AED will be accepted for payment.
- 4.2. The displayed price and currency at the checkout page will be the same price and currency printed on the Transaction Receipt and the amount charged to the card will be shown in your card currency.
- 4.3. Cardholder must retain a copy of transaction records and https://happyu.ae policies and rules.
- 4.4.**Restricted Countries**: We will not trade with or provide any services to OFAC and sanctioned countries.
- 4.5.**Payment Confirmation**: Once the payment is made, the confirmation notice will be sent to the client via email within 24 hours of receipt.

Article 5. CHANGES TO THE TERMS

- 5.1.**Right to Modify**: Happy U reserves the right, at its sole discretion, to update, revise, or otherwise modify these Terms at any time. Such changes may be made to reflect operational, legal, or regulatory requirements, or to improve the clarity, functionality, or user experience of the Website.
- 5.2. **Notification of Changes**: Where feasible, notice of material changes will be provided by updating the "Last Updated" date at the top of these Terms and, where appropriate, through prominent notice on the Website, via email, or through user accounts. Users are encouraged to review the Terms periodically to stay informed of any updates.
